




#### Winston Churchill said:

## 1<sup>st</sup> of 5 things to work to legislatively change

Government holding property rights (a natural right) in higher legal status than the PRIMARY natural right of self-preservation.



### 2nd of 5 things to work to legislatively change

Eliminate government mandated "criminal empowerment zones" aka "disarmed victim zones" aka "pistol free zones" aka "gun free zones" where over 94% of "active killer" massacres happen.



### 3rd of 5 things to work to legislatively change

Constitutional Carry - no government permission slip should be "required by usurpation" to exercise a PRIMARY natural right.


There are currently 25 States honoring Constitutional Carry - with Michigan's very clear Constitution let's honor the right of every person with Constitutional Carry.

### 4th of 5 things to work to legislatively change

No "extreme risk protection orders" aka "Red Flag Laws" aka "Gun Confiscation Orders" - multiple basic rights are violated, including due process, presumption of innocence, right to be made aware of the charges against you, the right to face your accuser, the right to defend yourself against charges laid against you with counsel, etc...

### 5th of 5 things to work to legislatively change

Allow local school boards or local school referendums to implement programs such as "Faster Saves Lives" to save more children and staff in the event of a massacre. Each community at their own level of comfort. Please run a search and research the "Faster Saves Lives" program which is privately funded in our neighbor State to the South, Ohio.
